Mequon Code of Ordinances, Sec. 14-84. – Amusement license required.

- (a) It shall be unlawful for any person, firm or corporation to exhibit for public view for gain within the City of Mequon any circus, caravan, carnival, kiddy rides, shooting gallery, carousel or any other exhibition, show of, amusement, or carry on, or operate, or be concerned in carrying on or operating any such show, exhibition or business herein before specified unless there shall first be obtained therefore a license from the common council upon written application duly made and filed with the city clerk.
- (b) License Investigation. The City Clerk shall notify the Chief of Police and the City Fire Inspector of each application for any license provided under this section. These officials or their designees shall inspect or cause to be inspected each application and the premises to determine the application's fitness for the trust to be imposed. These officials shall furnish to the City Clerk, in writing, the information derived from such investigations accompanied by a recommendation as to whether the city should grant or deny the license.
- (c) Before the city shall grant any license to any applicant, the applicant shall file with the city clerk proof of insurance in form, with coverages and in amounts required by the city's then current insurance policies. (Each vendor/company should provide General Liability coverage with at least \$1,000,000 limit and the City should be listed as an additional insured).
- (d) Fee for license. The fee for the license required under subsection (a) hereof shall be computed, according to schedule establishing such fee for each vehicle, ride, show or amusement furnished, as set by the common council from time to time. The license shall not be granted for a period of more than three days.
