### **Preview of January 10 Common Council Meetings**

Starting at 6:45 P.M on Tuesday, January 10, the Mequon Common Council, meeting as the Committee of the Whole, will hear a presentation by GovHR about an employee classification and compensation study that was performed in 2022 for non-represented positions.

Starting at 7:30 P.M., the Common Council will hold its monthly meeting for January. The meeting will begin with a public hearing to consider amending a planned unit development (PUD) to allow 10 units for the property located directly west of 11649 N. Port Washington Road. Following the public hearing consideration of the requested amendment, the Common Council will consider a number of other items, including:


- 1. Approving a development agreement for an 11-lot subdivision on the property located at 10766 North Torrey Drive
- 2. Amending Chapter 2 of the Municipal Code relating to electronic attendance at City meetings (first reading)
- 3. Amending Chapter 50 and Section 46-133 of the Municipal Code in relation to nuisances within the City involving noise (first reading)
- 4. Amending the City Code to establish banquet facilities as a conditional use in the B-2 (Community Commercial), TC (Town Center), and AC (Arrival Corridor) Zoning Districts and conference centers as a conditional use in the B-2, B4 (Business Park) and Ulao Creek Mixed-Use Zoning Districts
- 5. Amending Chapter 2 of the Municipal Code to eliminate the position of emergency dispatcher
- 6. Authorizing a transfer of \$36,661 from the Information Technology (IT) 2022 Budget to the IT Division's Capital Account to complete planned network upgrades in 2023
- 7. Approving the purchase of two back-up sewer pumps and appurtenances from Wisconsin Pump Works in the amount of \$149,319

## Special Election for District 8 is Tuesday, January 10





## County Line Road to Close Long-Term Starting January 10

The Wisconsin Department of Transportation is continuing work on the 14-mile, I-43 North-South reconstruction project. On Tuesday, January 10, County Line Road between Port Washington Road and Pheasant Lane is scheduled to close to traffic by 6:00 A.M. for bridge and roadway reconstruction through mid-2023. Also, Port Washington Lane between County Line Road and El Rancho Drive will close as well. Motorists are encouraged to use County Line, Range Line, Brown Deer and Port Washington roads to get around this planned, long-term closure. Access to businesses and residences will be maintained throughout these closures.



## **Health Department Offering Free Radon Test Kits**

During National Radon Action Month, the Washington-Ozaukee Public Health Department is encouraging homeowners to test their residences for radon by offering free test kits to residents. They are asking residents to bring a non-perishable food item in exchange for a free test kit. All items collected during this outreach event will be donated to a local food bank. Please note that postage on the test kit is not included. Test kits will be offered on Monday, March 13 from 9:00 A.M. – 1:00 P.M. at Mequon City Hall (use the south entrance).
