Preview of February 14 Common Council Meetings

Starting at 6:45 P.M on Tuesday, February 14, the Mequon Common Council, meeting as the Committee of the Whole, will receive an overview of the expenditures and contract awards for the final phase of the public improvement projects in Town Center Tax Increment District (TID) No. 3. The project's estimated cost of \$5,365,627 will cover the reconfiguration of Mequon Road, OIT crossing improvements, overhead utility burial, street lighting, streetscaping, signage, land acquisition, and ancillary maintenance.

Thereafter, at 7:15 P.M., the Common Council will meet as the City's Water Utility Commission to consider an intergovernmental agreement with the Village of River Hills for municipal water service, a water services agreement with the Village of River Hills for the River Hills Tax Increment District (TID) infrastructure project, a water service agreement and water utility easement with the Grove at River Hills, and a water services agreement for the One North Project in the Village of Bayside.

Starting at 7:30 P.M., the Common Council will hold its monthly meeting for February. The meeting will begin with newly elected District 8 Alderman Bill Gebhardt taking the Oath of Office. Following the swearing in, the Common Council will consider a number of items, including:

1. A development agreement for a 37 single-family lot subdivision on the property located at 1310 West Highland Road, known as Highland Meadows
2. An amendment to Chapter 2 of the Municipal Code relating to electronic attendance at City meetings
3. The purchase and implementation of electronic poll books, supplies, and training in an amount not-to-exceed \$90,000
4. A Town Center business loan between Bank Five Nine and Tamatito, a restaurant located at 6300 West Mequon Road, in the amount of \$25,000
5. An amendment to the City's template Memorandum of Understanding for private water trusts operating in the public right-of-way, to reference the City's standard specifications for land development
6. The installation of widened paved shoulders along Highland Road from Wauwatosa Road to the railroad crossing west of Cedarburg Road
7. Rejecting a bid for the City Hall roof replacement contract to Noffke Roofing and awarding the contract to Alois Roofing and Sheet Metal in the amount of \$335,995
8. Supplemental inspection services in excess of \$25,000 during the 2023 construction season with the following engineering firms: GRAEF, Kapur & Associates, R.A. Smith, Ruekert-Mielke, and SEH



Sign-up for County's Emergency Notification Alert System

As the Police Department continues to work with Ozaukee County as they assume emergency dispatching responsibilities on behalf of the City, the Department would like to advise Mequon residents of an emergency notification alerting system that is available to all residents of Ozaukee County. Residents have long known that they may call 911 for police, fire or medical assistance. Additionally, the Ozaukee County Sheriff's Office, Public Health Department, and Emergency Management Division participate in a mass alert notification system called Alert Sense, which is similar to a reverse of the 911 system. The County Dispatch Center, either on its own or at the request of City Officials, can send voice and text messages that alert the community to a variety of emergency and non-emergency circumstances, such as a crime/imminent danger, evacuation alert, hazardous materials, local area emergency, or missing

In addition to the elected positions of Mayor and Alderman on Mequon's eight-member Common Council, the City is also served by nearly fifteen separate boards, commissions and committees comprised of residents appointed by the Mayor and Common Council. These include a number of bodies devoted to community development and planning (Architectural Board, Board of Appeals, Economic Development Board, Landmarks Commission, Planning Commission) as well as to the upkeep and preservation of the City's natural resources (Tree Board, River Advisory Committee). Additionally, a number of groups also address matters related to Mequon's quality of life (Bike & Pedestrian Way Commission, Festivals Committee, Library Board, Park & Open Space Board) while others focus on very specified functions in support of the organization and/or community (Board of Police Commissioners, Board of Review, Ethics Board). Typically, most appointed terms run for a period of three years, with the Mayor and Council approving a large majority of appointments or re-appointments each April during the City's annual Organizational Meeting. 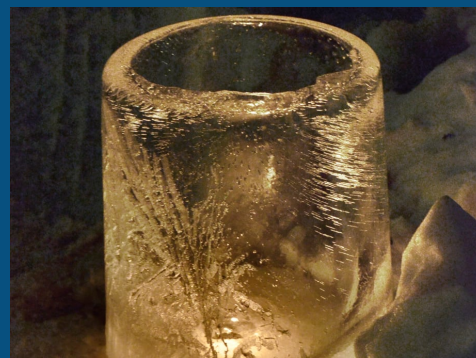
Absentee Voting Continues for Spring Election

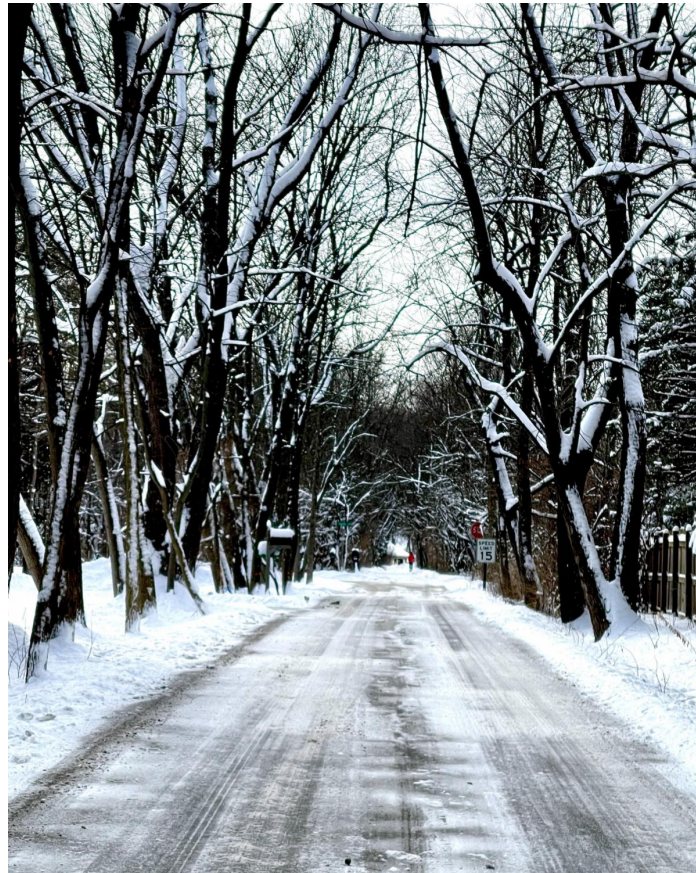
