Officer-Involved Critical Incident Investigation Continues

The Wisconsin Department of Justice (DOJ) Division of Criminal Investigation (DCI) is currently investigating an officer-involved critical incident in Mequon that occurred on the afternoon of Wednesday, May 17. At approximately 3:30 P.M., Mequon Police Officers responded to a report of shots fired in the 3100 block of Bonniwell Road. When officers arrived, the subject was barricaded in a residence. The subject eventually exited the residence and discharged a firearm toward officers, who then exchanged gunfire and struck the subject. Officers attempted to render aid; however, the subject was pronounced deceased at the scene. No law enforcement officers were injured in this incident. The full press release can be read [here](#). Special Election Set for Assembly District 24 Vacancy

During the Spring Election held on April 4, State Assembly District 24 Representative Dan Knodl was elected to represent State Senate District 8. To fill the vacated Assembly District 24 seat, Governor Tony Evers has called a Special Election for Tuesday, July 18. This will only involve those residents living in Assembly District 24, namely Wards 1, 2, 3, 4, 6, 10, 11A and 12 (see ward map [here](#)). If a primary is needed, it will take place on Tuesday, June 20. For both elections, voters can report to their normal polling sites between 7:00 A.M. – 8:00 P.M.
