Recap of September 12 Common Council Meetings

On Tuesday, September 12, the Mequon Common Council held its monthly meeting in the Council Chambers at City Hall. During the Committee of the Whole portion of the meeting, the Council reviewed and discussed proposed amendments to Chapter 62 of the Sign Code.

Thereafter, the Common Council, meeting as the Mequon Municipal Water Utility Commission, reviewed a draft update of the City's Water Utility Master Plan. During the business portion of the regular Common Council meeting, the Council acted to:

- Amend the City's Operating Budget for Fiscal Year 2023 to adjust budgeted amounts within the Department of Public Works due to unanticipated repairs and material cost increases in a net amount not-to-exceed \$36.576
- Approve a State/Municipal agreement for a Bicycle and Pedestrian Planning Study with the Wisconsin Department of Transportation
- Approve the purchase of a replacement compact track loader with related attachments from Fabick Cat in the amount of \$89,750

SOFD Board Approves 2024 Budget

On September 13, the Southern Ozaukee Fire & EMS Department Board approved its budget for 2024. The 2024 budget uses available Ozaukee County ARPA funding, an adjustment to some ambulance transport fees, and a proposed 4.28% levy increase for operations. The 2024 budget also includes the addition of one firefighter/paramedic position. Upon the hiring of the additional firefighter/paramedic, daily staffing will be seven personnel—one full-time battalion chief, three full-time firefighters and three paid-on-call



members. There is also a contingency of \$200,000, which is approximately 5% of the operational budget, and a capital contribution totaling \$130,285.

Wisconsin law allows for the communities of joint fire departments to use the levy limit exemption if the combined total of assessed charges to the municipalities does not exceed CPI + 2%. As proposed, the 2024 SOFD budget qualifies for this exemption.

Meguon Road Interchange Reconstruction Starts

As part of the I-43 North-South expansion project, the Mequon Road Interchange Segment began this week, with scheduled completion in mid-2025. This project includes reconstruction and expansion of 2.3 miles of I-43 between Glen Oaks Lane and Donges Bay Road, reconstruction of the Mequon Road interchange, and the construction of a noise wall along the west side of I-43, just south of Mequon Road. On Wednesday, eastbound and westbound Mequon Road, between the I-




43 northbound ramps and Port Washington Road were reduced to one lane each way through mid-2025. The I-43 northbound exit ramp to Mequon Road is scheduled to remain open with reduced capacity through early 2024. Elsewhere, a full closure of the Highland Road entrance ramp to I-43 northbound was also initiated, and will remain in effect until late September for ramp tie-in work. Motorists should expect overnight lane and ramp closures along I-43 while these project phases are completed.
