Recap of December 12 Common Council Meetings

On Tuesday, December 12, the Mequon Common Council held its monthly meeting in the Council Chambers at City Hall. During the Committee of the Whole portion of the meeting, the Council discussed the planning process for development of the City's next Community Survey. A Legislative update was also provided by the City Attorney, providing an overview of statutory law changes that may potentially impact City ordinances or policies starting next year.

Thereafter, the Common Council held its monthly meeting. During the business portion of the regular Common Council meeting, the Council acted to:

- Authorize the final plat for an 11-lot single-family residential subdivision located at 10766 Torrey Drive
- Approve the City's Insurance Program for Fiscal Year 2024 with the League of Wisconsin Municipalities Mutual Insurance, in the estimated amount of \$395,308
- Appoint Lester Ahrens as the Statutory City Assessor through December 31, 2025
- Award a contract for Long-Term Disability Insurance and Employee Assistance Program Services to Sun Life Assurance Company of Canada for an annual estimated premium of \$23,690
- Award a contract for construction of a combined concession and restroom facility at Lemke Park to Altius Building Company in an amount not-to-exceed \$984,500
