NOTE 2: Application fees are paid for any item requiring Architectural Board approval. Fees are waived for subsequent appearances if requested by the Architectural Board. Re-submittal at applicant's request shall require a new application fee.	
NOTE 3: Square foot area shall be defined as follows: The living area of the building enclosed by the interior surface of the exterior walls excluding the basement area, unless the basement area complies with the building code, permitting human habitation.	
NOTE 4: In determining cost, all construction shall be included with the exception of heating, air conditioning, electrical and plumbing work.	
NOTE 5: State of Wisconsin, Uniform Dwelling Code ILHR 21.125 supersedes Chapter 3, Section 3.17 of the Zoning Code.
