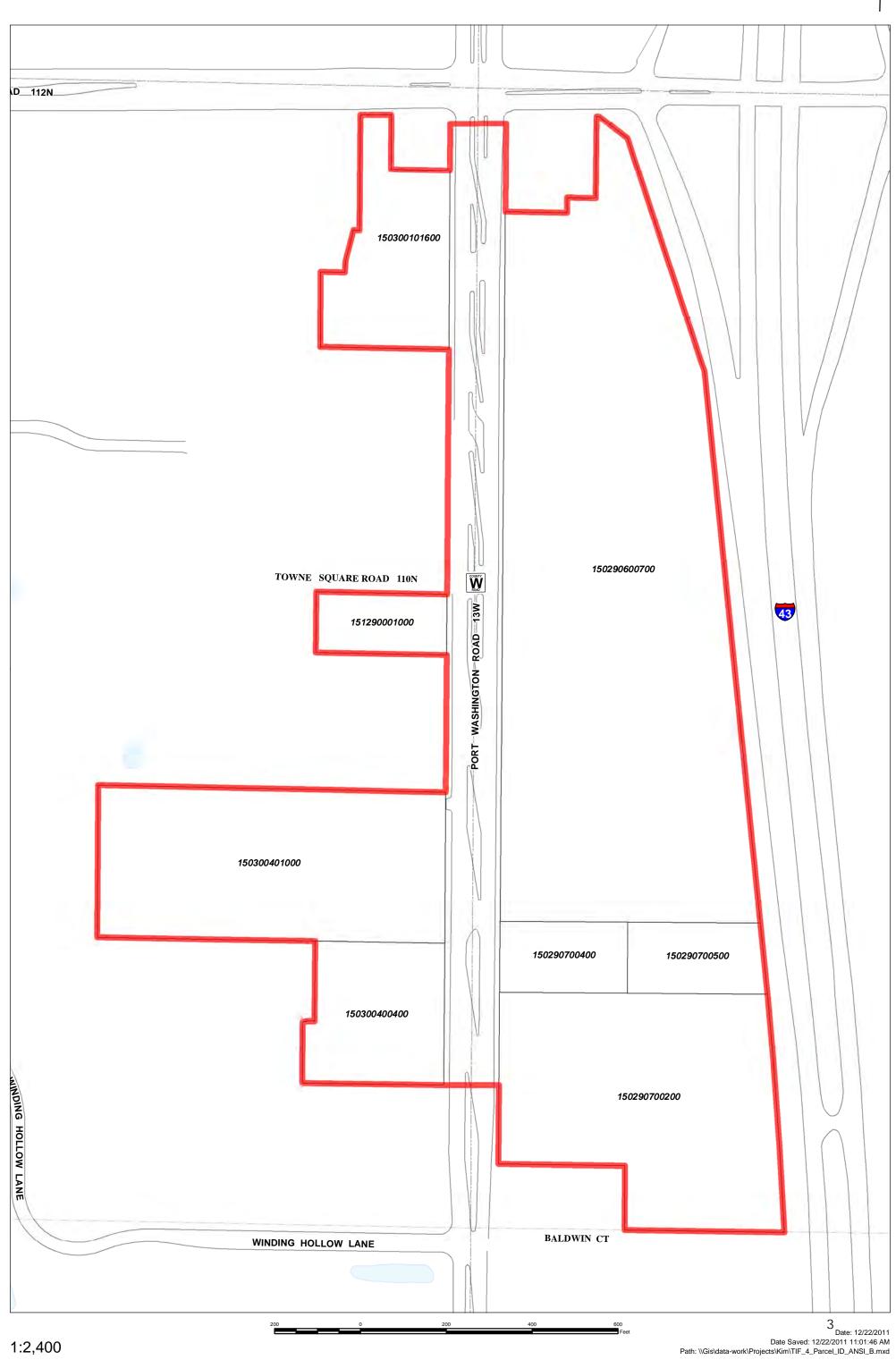

Construction of a Landmark Credit Union occurred in 2020. Two new multi-tenant retail/service structures are approved and likely built in 2021.			

	The City's plan is to only provide pay-as-you-go incentives for development within this District. The adopted project plan allows for approximately \$5 million in project costs. The City anticipates approximately \$2,281,850 in costs yet to be undertaken.
