WEAPONS DISCHARGE PERMIT

INSTRUCTIONS:

1. Fill out your personal information at the top of the permit.
2. Sign the bottom of the permit.
3. The property owner(s) fill out the information in the second section of the permit unless it is for MMSD properties.
4. Bring your photo I.D. and the completed permit to the Mequon Police Department for processing.
- 5. No permit is valid unless the original permit application is returned to the Mequon Police Department and replaced with an approved permit**

EVERY ATTEMPT WILL BE MADE TO REVIEW YOUR APPLICATION WITHIN 5 BUSINESS DAYS AFTER IT IS RECEIVED AT THE MEQUON POLICE DEPARTMENT.

SINGLE PROJECTILE HUNTING REQUIRES INSPECTION OF THE AREA TO BE HUNTED BY AN OFFICER OF THE MEQUON POLICE DEPARTMENT. INSPECTIONS WILL BE ATTEMPTED WITHIN 5 BUSINESS DAYS OF APPLICATION APPROVAL. NO SINGLE PROJECTILE HUNTING IS ALLOWED WITHOUT THIS APPROVAL.

The fee for a Weapons Discharge Permit SHALL NOT BE REFUNDED. Permit replacement fee is \$5.00.

MEQUON CODE OF ORDINANCES: Chapter 46, Section 46, 105 through 116

No person shall carry or discharge a rifle at any time in the City of Mequon.

No person shall, within the designated closed area, carry or discharge any weapon other than a bow and arrow, and then only as specifically provided and subject to all other applicable provisions, or by review of the police chief or his designee.

No person shall carry or discharge any weapon as herein defined, except as allowed under the provisions of these Ordinances, in an area bounded by the Lake Michigan shore on the east, County Line Road on the south, State Trunk Highway 57 and Cedarburg Road on the west, and Highland Road on the north, or on, upon, or across the Milwaukee River in the City of Mequon.

No person shall discharge a weapon on or across the Milwaukee River where a platted subdivision is located across the Milwaukee River or within 500 feet of the Milwaukee River in the City of Mequon.

No person shall carry or discharge a weapon within 300 feet of an occupied dwelling, unless the owner or occupant of the adjoining property has first signed such person's Weapons Discharge Permit and such Weapons Discharge Permit is on file at the Mequon Police Department.

Transportation of weapons to or from areas where the carrying or discharge of a weapon is permitted, or into or out of the city, shall not constitute "carrying" the weapon provided the weapon is unloaded and completely enclosed in a case or dismantled so that it cannot be fired or discharged.
